




Growth and Assessment of Chipola's Dual Enrollment Program

The dual enrollment program at Chipola College has grown significantly. Qualified high school students can take college classes that also count toward their high school graduation requirements through the dual enrollment program. The number of high school students in the college district who have benefited from Chipola's dual enrollment offerings has increased by 8% since the fall semester of 2021.




Chipola evaluates its dual enrollment program using three metrics: 1) grade distributions for students in dual enrollment courses in high school versus grade distributions for all students enrolled in the same courses on campus; 2) the fall-to-fall retention rate of students who have previously earned dual enrollment credits versus those who have not; and 3) the graduation rate of students who have previously earned dual enrollment credits versus those who have not. The following graphs show the results of these three measures.

Summary of findings:

- ✓ Higher final courses grades than those earned by students in same courses on campus.
- ✓ Higher retention rate for students with prior dual enrollment credits.
- ✓ Higher graduation rate for students with prior dual enrollment credits.
