# 2023 and 2024 Employee Survey Results

Chipola College conducts an employee survey each spring semester and uses the results to make operational improvements. Fifty-five employees completed the 2024 survey compared to 56 in 2023. Employees were asked to rate five areas of the college: 1) Student Resources and Educational Support Services, 2) Administrative Functions and Offices, 3) Physical and System Infrastructures, and 4) Work and Learning Environments. The following tables show the means of employees' ratings in each of the areas for 2023 and 2024. The rating scale of responses reported in the first four tables is 5 = very good, 4 = good, 3 = neutral, 2 = poor, and 1 = very poor.

## **Student Resources and Educational Support Services**

The majority of employees rated student resources and educational support services as good or very good. The average rating for resources and services was 4.56 in 2024 compared to 4.41 in 2023.
